RELEASE OF LIABILITY

In consideration of the undersigned's participation in the U.S. Ensign National Championship (the "Regatta") sponsored by US Sailing, the Ensign Class Association, Ensign Fleet 31 (the "Sponsor"), and hosted by Ensign Fleet 31 (the "Hosts") on August 15-19, 2010 the undersigned Participant ("Participant"), and if such Participant is a minor, the Participant's parent or legal guardian by countersigning below, on behalf of themselves and their respective heirs, executors, administrators, personal representatives, and next of kin (collectively with Participant, "Releasers"), hereby forever waive, release and discharge each of the Sponsors, Clark Township, Mertaugh Boat Works, Floation Docking Systems, Hessel Harbor Association, the Host, and their respective parents, subsidiaries, affiliates, owners, members, managers, employees, officers, directors, agents, representatives, successors, and assigns (each a "Released Party") from any and all claims, demands, damages, judgments, executions, rights of action or cause of action, present and future, whether the same be known, anticipated, or unanticipated, which a Releaser may have, or claim to have, against any released Party resulting from death, personal injury, property damage or other loss Releaser may sustain as a result of participating in the Regatta or other activities related thereto.

THIS RELEASE IS INTENDED TO DISCHARGE EACH RELEASED PARTY FROM ANY AND ALL LIABILITY ARISING OUT OF OR CONNECTED IN ANY WAY WITH RELEASER'S PARTICIPATION IN THE REGATTA EVEN IF THAT LIABILITY ARISES OUT OF NEGLIGENCE OR CARELESSNESS ON THE PART OF ANY RELEASED PARTY.

Sailing is an activity that has an inherent risk of damage and injury. Competitors in this event are participating entirely at their own risk. See RRS 4, Decision to Race. The race organizers (organizing authority, race committee, protest committee, host clubs, sponsors, or any other organization or official) will not be responsible for any damage to any boat or other property or the injury to any competitor, including death, sustained as a result of participation in this event. By participating in this event, each competitor agrees to release the race organizers from any and all liability associated with such competitor's participation in this event to the fullest extent permitted by law, I hereby waive any rights I may have to sue the race organizers involved with the event with respect to personal injury or property damage suffered by myself or my crew as a result of our participation in this event and hereby release the race organizers from any liability for such injury or damage.
